Who we are

Community Medical Centers is a locally owned, not-for-profit, public-benefit organization. Based in Fresno, California, Community is the region's largest health care provider and private employer. We operate three hospitals – Community Regional Medical Center, Clovis Community Medical Center and Fresno Heart & Surgical Hospital – several long-term care, outpatient, other health care facilities and a physician residency program in conjunction with the University of California, San Francisco.

Community serves as the area's "safety-net" provider, and in fiscal year 2010-2011, provided nearly \$134 million in "community benefits" – which includes charity care and uncompensated services to the medically underserved. We are also home to the region's only Level 1 trauma center between Los Angeles and Sacramento.
